#### **BACKGROUND**

The League of Arab States was founded in March 1945. Its main goal is to "draw closer the relations between member States and coordinate collaboration between them, to safeguard their independence and sovereignty, and to consider in a general way the affairs and interests of the Arab countries." It serves as the regional organization of Arab states, with a focus on developing the economy, resolving disputes and coordinating political issues.

In February 2017, the Economic and Social Council of the LAS approved the establishment of a Arab High Level Sustainable Development Committee to coordinate the efforts of the region with regard to the implementation of the SDGs. The third meeting of the Committee, in December 2017, approved the establishment of a Subcommittee for Hunger Eradication, Food Security and Sustainable Agriculture in the Arab Region. The membership of the Subcommittee was composed of the Arab Organization for Agricultural Development (AOAD), FAO, the World Food Programme (WFP), the Economic and Social Commission for Western Asia (ESCWA) and the Department of Sustainable Development and International Cooperation of the LAS. Its mandate was to monitor the achievement of SDG 2 in terms of ending hunger, improving food security and nutrition, and promoting sustainable agriculture and other integrated and related goals. It would do this by developing an Arab plan to support Arab countries' efforts in implementation of the second goal of the SDGs, thus advancing FAO's Zero Hunger Initiative in the region. In order to achieve this aim, the Secretariat of the Subcommittee for Ending Hunger in the Arab Region requested technical assistance from FAO.

#### **IMPACT**

As the strategy developed under the project has not yet been implemented, its eventual impact remains to be seen. However, as implementation proceeds, the strategy is expected to contribute to sustained food and nutrition security, agricultural inclusive growth and socio-economic development throughout the region.

#### **ACHIEVEMENT OF RESULTS**

The project successfully developed a Strategic Framework for Zero Hunger in the Arab Region for endorsement by the Economic and Social Council (ECOSOC) of the LAS. This is one step forward towards the endorsement of the initiative by Heads of States and its implementation by member countries.

Despite the delay and difficulties imposed by the COVID-19 pandemic in the region, the project was able to deliver all three planned outputs. The first output concerned the preparation of an analytical document that would inform a Strategic Framework and Action Plan. These were prepared and endorsed by the LAS Arab Sustainable Development Committee in September 2021. The second output was devoted to raising the awareness of decision-makers of the contribution made by their specific sectors to resolving food insecurity and all forms of malnutrition. During Arab Sustainable Development Week (ASDW), organized annually by the LAS, a special session entitled "Towards Zero Hunger in the Arab Region" was organized in November 2019. A second Zero Hunger panel discussion was organized during the 41st FAO Conference in June 2019. Both these events helped to build the awareness of the role to be played by decision-makers in achieving Zero Hunger. The final output regarded awareness-raising among key stakeholders. The regional and subregional workshops originally envisaged could not take place because of COVID-19 restrictions. As an alternative, online consultations were held with 14 Arab countries in December 2021. A questionnaire was also prepared to gather the views of all member countries to inform the Strategic Framework and Action Plan.

#### IMPLEMENTATION OF WORK PLAN AND BUDGET

The project achieved its envisaged outcome despite delays in some activities because of the COVID-19 pandemic. The adoption of online consultations to replace the planned regional and subregional workshops led to considerable savings and the original budget of USD 500 000 was reduced to USD 155 000 as a result.

The project faced minimum risks, other than those of the COVID-19 pandemic, and caused no environmental or social risks.

#### FOLLOW-UP FOR GOVERNMENT ATTENTION

It is recommended that the Strategic Framework for Zero Hunger in the Arab Region be endorsed by the Heads of States concerned and that it be implemented in all member countries.

#### **S**USTAINABILITY

#### 1. Capacity development

Food and nutrition security, the major focus of the project, receives considerable attention in the agenda of member countries. Most countries in the region have existing policies and institutions dealing with the issues. In addition, an increasing number of member countries have developed or are developing national food security strategies. The Strategic Framework developed by the project will aid member countries in revising their strategies to address food insecurity and malnutrition.

The Strategic Framework proposes an Action Plan to operationalize seven identified priorities and to enable their contextualization and adoption by governments and implementing partners at national level. The Framework was developed to support the Subcommittee for Eliminating Hunger of the League of the Arab States. In addition to member States, members of the Subcommittee include AOAD, FAO, WFP, ESCWA and the Department of Sustainable Development and International Cooperation of the LAS, as well as academia and civil organizations. As such, a strong partnership among stakeholders has already been established.

With regard to implementation, it is proposed that the Subcommittee for Ending Hunger of the Department for Sustainable Development and International Cooperation be responsible for overseeing implementation and that it discuss the additional capacity needed to assume this management responsibility as part of the plan-making process.

#### 2. Gender equality

The Strategic Framework does not provide distinctions based on gender. By achieving food and nutrition security at regional, national, family and individual levels, both men and women will benefit.





#### 3. Environmental sustainability

The Strategic Framework places high priority on sustainably increasing agricultural productivity through the sustainable management of natural resources.

## 4. Human Rights-based Approach (HRBA) – in particular Right to Food and Decent Work

Except for the right to food, the project did not directly address human rights. However, the Strategic Framework places high priority on enhancing smallholders' access to production inputs and services, and to improvements in public services in rural areas, both of which are expected to contribute to the creation of gainful employment and entrepreneurship opportunities for rural youth, women and other targeted groups.

#### 5. Technological sustainability

The capacity of the governments of the member countries to implement the strategic framework, given the political will to do so, is high.
